 - Inclement weather and extreme heat
 - First Amendment groups
 - Last Friday two men from South Dakota came to Wood County Health Department's building
 - They came with cameras rolling and filmed rooms throughout the building
 - Antagonized staff, walked into rooms on all levels of building
 - Put video on You Tube and misidentified Sue Smith (was a different Sue in video); since Sue Smith has gotten hundreds of hate mail and voice mails
 - Now posting signs throughout building that are labeled public and private and doing a staff training on how to handle these groups
