

NCW HERC Financial Accountant Agreement and Scope of Work

This agreement is between ______ and North Central Wisconsin Healthcare Emergency Readiness Coalition, also known as NCW HERC.

Timeline: The term of this agreement is effective July 1, 2023, through June 30, 2024.

SCOPE OF WORK:

- General accounting and bookkeeping skills
- Knowledge of budgets and organizing income and expenses into line items
- Experience with developing financial reports
- Monitor, update, and report on the state of the HERC budget: variances, year-to-date (YTD), identified discrepancies

DELIVERABLES & EXPECTATIONS:

- Review and understand the HERC responsibilities related to Fiscal Agent reporting to the Office for Preparedness and Emergency Health Care (OPEHC)
- Maintain an accounting ledger for the NCW HERC Board in accordance with DHS Fiscal Agent Contract Requirements
- Routinely meet with the HERC and RTAC Coordinators to review and update budgets and YTD expenses
- Develop monthly reconciliation reports for:
 - o NCW HERC Board
 - o NCRTAC Board
 - OPEHC
 - Provide a summary and field questions at monthly HERC Board Meetings
- Develop purchase order invoices for submission to OPEHC for payment to NCW HERC and NCRTAC
- Develop and file 1099s for NCW HERC Contractors
- Collaborate with the HERC to coordinate an independent audit
- Develop and submit a 990 EZ for NCW HERC

NCW HERC hereby agrees to release, indemnify, defend, and hold harmless _______, its officials, officers, employees and agents from and against all judgments, damages, penalties, losses, costs, claims, expenses, suits, demands, debts, actions and/or causes of action of any type or nature whatsoever, including actual and reasonable attorney's fees, which may be sustained or to which they may be exposed, directly or indirectly, by reason of personal injury, death, property damage, or other liability, alleged or proven, which is determined to be caused by the negligent or intentional acts or omissions of NCW HERC's officers, officials, employees, agents or assigns.

NCW HERC does not waive, and specifically reserves, its rights to assert any and all affirmative defenses and limitations of liability as specifically set forth in Wisconsin Statutes, Chapter 893 and related statutes.

TERMINATION/REDIRECTION: Either party may terminate this contract on thirty (30) calendar days written notice, or if prior to such action, the other party materially breaches any of its representations, warranties or obligations under this contract. Except as may be otherwise provided in this contact, such breach by either party will result in the other party being responsible to reimburse the non-defaulting party for all costs incurred directly because of the breach of this contract and shall be subject to such damages as may be allowed by law including all attorneys' fees and costs of enforcing this contract. Redirection and modifications to deliverables may be made at the agreement of both parties. If done, an amended contract will be developed and signed.

Pay: NCW HERC will pay _______\$4,800 for the term of the contract. _______ will invoice NCW HERC in equal, monthly or quarterly installments. Mileage expense to complete the assigned contract is included inside of the base contract. Any mileage outside of the base contract will be reimbursed at the current reimbursement rate, as approved by NCW HERC Board. The NCW HERC Board reserves the right to prorate this contract should there be an interruption in the ability to complete deliverables or expectations. This will be conducted by a majority board vote and thirty calendar day written notice to ______. The contract will be reviewed and revised, as necessary, for renewal at the end of the identified contract period.
